



Pursuant to the article 82, stav 3 of the Law on Local Self-Government (the Official Gazette of Republika Srpska, number: 97/16), article 89 of the Statute of the City of Prijedor (the Official Gazette of Republika Srpska), number: 12/17), the Mayor of the City of Prijedor brings

REGULATIONS

on organizing the International Choir Festival

“ZLATNA VILA“

Prijedor

Article 1

- (1) This Regulation determines the objectives, bodies, principles of organizing, manners of financing as well as attached documents of the International Choir Festival „Zlatna vila“ Prijedor (in the further text Festival).

Objectives and character of the Festival

Article 2

- (1) The Festival is a permanent cultural good and traditional international cultural manifestation of the City and republic importance which is held biennially (in even number year) in Prijedor in the first half of May.
- (2) The objective of the Festival is to affirm the most valuable classic and contemporary works of domestic and foreign authors in the field of choral music, empower the development of choral singing in our region, develop the critical relation towards music values, mutual introduction and social cohesion as well as to enable the citizens to be present at international cultural program of high artistic quality.

Article 3

- (1) The Festival conducts its role in popularizing and affirming the choral singing during the entire year and in the year it is not held through activities of the Organizing Board and Artistic Council of the Festival. This role reflects in organizing the Review of Children’s Choral Singing “Mala vila“, marking the World Choral Day, organizing concerts and monitoring the work of choirs in Prijedor.
- (2) The manner of organizing the Review of Children’s Choral Singing “Mala vila“ has been regulated by separate regulation.

Article 4

- (1) The Festival has an international and competitive character.
- (2) All details related to the manner of applying and performing of choirs have been regulated in a separated act: Propositions of the International Choir Festival "Zlatna vila".

Organizer, bodies and acts of the Festival

Article 5

- (1) The executive organizer and sponsor of the Festival is the City of Prijedor, and the sponsor is the Ministry of Education and Culture of the Government of Republika Srpska.
- (2) Co-organizers of the Festival are the Serbian Cultural Artistic Society "Dr. Mladen Stojanović" Prijedor, Serbian Singing Society "Vila" Prijedor and Public Institution Music School "Savo Balaban" Prijedor.

Article 6

- (1) The bodies of the Festival are the Organizing Board of the Festival, President of the Organizing Board of the Festival, Artistic Council of the Festival and Jury of the Festival.
- (2) The basic acts of the Festival are the Regulations on organizing the Festival, Propositions on participation at the Festival, Regulations on awards of the Festival, Regulations on work of Jury of the Festival and Regulations on organizing the Mala vila Review of Children's Choral Singing.

Organizing Board of the Festival

Article 7

- (1) The Organizing Board of the Festival has 7 -13 members and is appointed by the Mayor of the City of Prijedor at proposal of the Department of Social Affairs.
- (2) The Organizing Board is composed of representatives of cultural, educational and public life of the City of Prijedor.

Article 8

- (1) The Organizing Board of the Festival can fully decide and bring decisions if the session is attended by more than a half of members and decisions will be brought on the basis of majority of votes of present members.
- (2) The mandate of members of the Board is four years and it can be repeated.
- (3) Membership into the Organizing Board can cease prior to mandate expiry due to inactivity of a member, non-implementing conclusions and decisions of the Board or breakage of rules of the Festival and personal reasons of a member.
- (4) A decision on cessation of membership in the Organizing Board is brought by the Mayor of the City of Prijedor.

Article 9

- (1) The Organizing Board of the Festival performs the following affairs:
 - At proposal of the Artistic Council of Festival adopts the final proposal and refers to the Mayor for bringing the basic acts of the Festival: Regulations on organizing the Festival, Propositions

of the Festival, Regulations on work of Jury of the Festival, Regulations on awards of the Festival and Regulations on organizing the Mala vila Review of Children's Choral Singing;

- Appoint a Counting Vote Commission for Award of Audience;
- Appoint persons to hand awards to winning choirs;
- Brings all important decisions related to successful organization of the Festival;
- At proposal of the Artistic Council it adopts the list of participating choirs and members of the Jury;
- At proposal of the Artistic Council it adopts the accompanying programs of the Festival;
- Adopts the program of the Festival "Mala vila";
- Adopts the financial plan of the Festival;
- Adopts the Report on organizing of the Festival and Financial Report;
- Adopts the list of hosts to choirs;
- Adopts the program of marking the World Choral Day and
- Decides about other programs related to choral singing that are held in the area of the City of Prijedor.

Article 10

(1) The Organizing Board of the Festival has four regular sessions:

- At first session proposing participating choirs and members of the Jury and is announced the public call for participation at the Festival.
- At second session is reviewed the number of registered choirs and propose the accompanying program and financial plan of the Festival.
- At third session is adopted the accompanying program of the Festival, analyze the degree of as-yet organization and adopt certain obligations and tasks during the Festival.
- Fourth session is organized after holding Festival and reports on organizing and financial plan are adopted as well as analyze the manner of organizing the Festival.

(2) If needed, the Organizing Board may hold extraordinary sessions as well.

President of the Organizing Board of the Festival

Article 11

(1) President of the Organizing Board, by its function, is the Mayor of the City of Prijedor.

(2) President of the Organizing Board of the Festival performs the following affairs:

- Appoint and discharge members of the Organizing Board of the Festival;
- Appoint and discharge members of the Artistic Council of the Festival;
- Preside at sessions of the Organizing Board of the Festival;
- At proposal of the Organizing Board brings all regulations of the Festival and signs decisions and all other documents that are adopted by the Organizing Board of the Festival;
- Monitor the dynamic of organizing the Festival and accomplish financial plan and
- Out of members of the Organizing Board of the Festival appoint vice president that replaces him/her in performing affairs in case of his/her inability to be present.

Artistic Council of the Festival

Article 12

- (1) Artistic Council of the Festival is an expert body of the Organizing Board of the Festival that looks after the artistic value of participating choirs, quality of members of the Jury and artistic level of accompanying programs.
- (2) Artistic Council of the Festival has three members and is appointed by the Mayor at proposal of Department of Social Affairs.
- (3) Artistic Council brings its decisions by consensus.
- (4) The mandate of members of the Artistic Council is four years and can be repeated.
- (5) Membership into Artistic Council can cease prior to expiry of mandate due to inactivity of a members, non-implementing conclusions and decisions of the Organizing Board of the Festival and personal decision of a member.
- (6) President of the Artistic Council is automatically a member of the Organizing Board of the Festival as well.

Article 13

- (1) Artistic Council of the Festival performs the following affairs:
 - Propose to the Organizing Board choirs that will be directly invited to the Festival;
 - Select choirs that have been applied preliminary at the Festival at Public Call for participation at the Festival and make a selection of participant out of this category;
 - Propose to the Organizing Board members, president and secretary of the Jury;
 - Propose to the Organizing Board Propositions on organizing the Festival;
 - Propose to the Organizing Board Regulations on work of Jury of the Festival;
 - Propose to the Organizing Board Regulations on awards of the Festival;
 - Determine the schedule of choir performance at the Festival as well as schedule of mandatory rehearsals;
 - Propose to the Organizing Board accompanying program of the Festival.

Jury and awards of the Festival

Article 14

- (1) Jury of the Festival has 3 to 5 members and is appointed by the Organizing Board at proposal of the Artistic Council of the Festival;
- (2) The manner of Jury work is regulated by the Regulations on work of Jury.

Article 15

- (1) Festival's awards are given on the basis of a decision of the Jury and votes of audience.
- (2) The kinds and manner of the Festival awarding are regulated by separate act: Regulations on awards of the International Choir Festival "Zlatna vila".

Expert assistance, obligations of the co-organizer and funding

Article 16

- (1) Expert, technical and administrative affairs in the work of the Festival's bodies as well as other organizational affairs are performed by Department of Social Affairs of the City Administration of the City of Prijedor.

Article 17

- (1) Obligations of the Festival's co-organizers are as follows: applying for projects, organizing accompanying programs and via its representatives in the Organizing Board of the Festival, participation in completion of other affairs connected to organization of the Festival.

Article 18

- (1) The executive organizer and sponsor, the City of Prijedor, bears the funding of the Festival based on the financial plan adopted at the beginning of preparations for the Festival.
- (2) Aimed at decreasing subsidies by the City of Prijedor, the Festival can look for other sources of funding: public notice for projects in culture, sponsors and friends.

Final provisions

Article 19

- (1) Amendments to this Regulations are brought by the Mayor at proposal of the Organizing Board.
- (2) These Regulations shall enter into force on the eighth day following its publication in the "Official Gazette of the City of Prijedor".
- (3) By entering into force this Regulation, the Regulations on organizing the International Choir Festival "Zlatna vila" dated 4 February 2016, number 02 – 06 – 2/ 2016, will cease to have effect.
